No. 318/CS/1/2016 (1):- Whereas, the President of India has, by notification issued under section 12 of the Representation of the People Act, 1951(43 of 1951) and published in the Gazette of India on 4th March, 2016, been pleased to call upon the elected members of each of the Legislative Assemblies of the States, specified in column (1) of the TABLE below, to elect to the Council of States, the number of members specified against that State in column (2) of the said TABLE:

- (A) appoints, with respect to the said election;,
  - (a) the 11th March, 2016 (Friday), as the last date for making nominations;
  - (b) the 12th March, 2016 (Saturday), as the date for the scrutiny of the nominations;
  - (c) the 14th March, 2016 (Monday), as the last date for the withdrawal of candidatures;
  - (d) the 21st March, 2016 (Monday), as the date on which a poll shall, if necessary, be taken; and
  - (e) the 23rd March, 2016 (Wednesday), as the date before which the election shall be completed; and
- (B) fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken in all the above mentioned States on the date specified above for the election.
